PRIVACY POLICY

Devon Diesel Society Limited understands that your privacy is important to you and that you care about how your information is used and shared online. We respect and value the privacy of everyone who visits Our Site and will only collect and use information in ways that are useful to you and in a manner consistent with your rights and Our obligations under the law.

This Policy applies to Our use of any and all data collected by us in relation to your use of Our Site. Please read this Privacy Policy carefully and ensure that you understand it. Your acceptance of Our Privacy Policy is deemed to occur upon your first use of Our Site. If you do not accept and agree with this Privacy Policy, you must stop using Our Site immediately.

1. Definitions and Interpretation

In this Policy, the following terms shall have the following meanings:

“Account”	means an account required to access and/or use certain areas and features of Our Site;
“Cookie”	means a small text file placed on your computer or device by Our Site when you visit certain parts of Our Site and/or when you use certain features of Our Site. Details of the Cookies used by Our Site are set out in section 12, below;
“Our Site”	means this website, www.devondiesels.org.uk
“UK and EU Cookie Law”	means the relevant parts of the Privacy and Electronic Communications (EC Directive) Regulations 2003 as amended in 2004, 2011 and 2015; and
“We/Us/Our”	means Devon Diesel Society Limited, a company, registered in England and Wales under 03299431, registered charity under 1060193 whose registered address is 78 Brantwood Drive, Paignton, Devon. TQ4 5HY

2. **Information About Us**

Our Site – www.devondiesels.org.uk is owned and operated by Devon Diesel Society Limited, registered company in England and Wales under 03299431, registered charity under 1060193 whose registered address is; 78 Brantwood Drive, Paignton, Devon, TQ4 5HY.

3. **Scope – What Does This Policy Cover?**

This Privacy Policy applies only to your use of Our Site. It does not extend to any websites that are linked from Our Site (whether We provide those links or whether they are shared by other users). We have no control over how your data is collected, stored or used by other websites and We advise you to check the privacy policies of any such websites before providing any data to them.

4. **What Data Do We Collect?**

Some data will be collected automatically by Our Site, other data will only be collected if you voluntarily submit it, for example, when signing up for an Account or becoming a Member. Depending upon your use of Our Site and what information we require for you to become a Member, We may collect some or all of the following data:

- 1.1 Name;
- 1.2 Date of birth;
- 1.3 Gender;
- 1.4 Business/Company name;
- 1.5 Job title;
- 1.6 Home address;
- 1.7 Contact information such as email addresses and telephone numbers;
- 1.8 Preferences and interests;
- 1.9 IP address (automatically collected by hosting);
- 1.10 Web browser type and version (automatically collected by hosting);
- 1.11 Operating system (automatically collected by hosting); and
- 1.12 A list of URLs starting with a referring site, your activity on Our Site, and the site you exit to (automatically collected by hosting).

5. **How Do We Use Your Data?**

1.1 All personal data is stored securely in accordance with the principles of the Data Protection Act 1998. For more details on security see section 6, below.

1.2 We use your data to provide the best possible products and services to you.

This includes:

2.a.1 Contacting you as Member including sending you Our newsletters, magazines and any other information you are entitled to receive as a Member;

2.a.2 Providing and managing your Account;

2.a.3 Providing and managing your access to Our Site;

2.a.4 Personalising and tailoring your experience on Our Site;

2.a.5 Supplying Our products and services to you;

2.a.6 Personalising and tailoring Our products and services for you;

2.a.7 Responding to communications from you;

2.a.8 Supplying you with email newsletters and alerts that you have subscribed to (you may unsubscribe or opt-out at any time by emailing us to opt-out)

2.a.9 Market research.

1.3 With your permission and/or where permitted by law, We may also use your data for marketing purposes which may include contacting you by email and/or telephone and/or post with information, news and offers on Our products and/or services. We will not, however, send you any unsolicited marketing or spam and will take all reasonable steps to ensure that We fully protect your rights and comply with Our obligations under the Data Protection Act 1998 and the Privacy and Electronic Communications (EC Directive) Regulations 2003, as amended in 2004, 2011, 2015 and 2016.

6. How and Where Do We Store Your Data?

- 1.1 We only keep your data for as long as We need to in order to use it as described above in section 5, and/or for as long as We have your permission to keep it.
- 1.2 Your data will only be stored within the European Economic Area (“the EEA”) (The EEA consists of all EU member states, plus Norway, Iceland and Liechtenstein).
- 1.3 Notwithstanding the security measures that We take, it is important to remember that the transmission of data via the internet may not be completely secure and that you are advised to take suitable precautions when transmitting to Us data via the internet.

7. Do We Share Your Data?

- 1.1 We may share your data with other companies in Our group. This includes Our subsidiaries and/or Our holding company and its subsidiaries.
- 1.2 We may sometimes contract with third parties to supply products and services to you on Our behalf. These may include payment processing, delivery of goods, search engine facilities, advertising and marketing. In some cases, the third parties may require access to some or all of your data. Where any of your data is required for such a purpose, We will take all reasonable steps to ensure that your data will be handled safely, securely, and in accordance with your rights, Our obligations, and the obligations of the third party under the law.
- 1.3 We may compile statistics about the use of Our Site including data on traffic, usage patterns, user numbers, sales and other information. All such data will be anonymised and will not include any personally identifying information. We may from time to time share such data with third parties such as prospective investors, affiliates, partners and advertisers. Data will only be shared and used within the bounds of the law.
- 1.4 In certain circumstances, We may be legally required to share certain data held by Us, which may include your personal information, for example, where We are involved in legal proceedings, where We are complying with the requirements of legislation, a court order, or a governmental authority. We do not require any further consent from you in order to share your data in such circumstances and will comply as required with any legally binding request that is made of Us.

8. **What Happens If Our Business Changes Hands?**

- 1.1 We may, from time to time, expand or reduce Our business and this may involve the sale and/or the transfer of control of all or part of Our business. Data provided by users will, where it is relevant to any part of Our business so transferred, be transferred along with that part and the new owner or newly controlling party will, under the terms of this Privacy Policy, be permitted to use the data for the purposes for which it was originally collected by Us.
- 1.2 In the event that any of your data is to be transferred in such a manner, you will not be contacted in advance and informed of the changes.

9. **How Can You Control Your Data?**

- 1.1 When you submit information via Our Site, you may be given options to restrict Our use of your data. In particular, We aim to give you strong controls on Our use of your data for direct marketing purposes (including the ability to opt-out of receiving emails from Us which you may do by unsubscribing using the links provided in Our emails and at the point of providing your details).

10. **Your Right to Withhold Information**

- 1.1 You may access Our Site without providing any data at all.
- 1.2 You may restrict your internet browser's use of Cookies. For more information, see section 12.

11. **How Can You Access Your Data?**

You have the legal right to ask for a copy of any of your personal data held by Us (where such data is held) on payment of a small fee which will not exceed £10. Please contact Us for more information using the details below in section 13.

12. **Cookies**

Our Site may place and access certain first party Cookies on your computer or device. First party Cookies are those placed directly by Us and are used only by Us. We use Cookies to facilitate and improve your experience of Our Site and to provide and improve Our products and services.
